## City of Milano City Council Meeting Minutes Monday, June 24 2024 – 6:30 pm Milano Civic Center 120 West Avenue E Milano. TX 76556

Mayor Westbrook called the meeting to order at 6:38 pm. The mayor established there was a quorum. Councilman Bryan Woods was absent. The meeting opened with greetings from Mayor Westbrook. The invocation was given by Chad Lagrone and the Pledge of Allegiance was led by the Mayor.

Brenda Neidhart stated there is a tree in the ditch and laying on their property and that this is not acceptable. Their property is still flooding. The culvert needs to be cleaned out on Avenue A. They are getting stuck in the street and there is 3' of sand that has washed in and the engineers need to go back to school. They cannot mow their land because of all this dirt that has washed in.

Robert Blake told the council that no one was told about the ditches being dug along N 5<sup>th</sup> St. They all wish someone had told them about this. All the residence should have received notice in writing by mail that this work was going to be done. My wife and I had to buy additional culverts at a cost of over \$1,700 dollars and that they are now full of mud and debris. The ditches have washed out and caused erosion all along the street. The council members should drive down to the end of N 5<sup>th</sup> St and look up to the school and look at the mess the street is in. The culverts are all messed up and all difference sizes. Why couldn't they have all been cement like the ones at 5<sup>th</sup> and Ave B. They would have at least been the same size. The engineers should have aligned them so they would not wash out our lawns and erode the 5<sup>th</sup> Street, which is in terrible condition.

Councilman Edward Lenz made the motion to approve the city council meeting minutes of the May 20, 2024 regular city council meeting and pay the June bills for City of Milano. Councilman Chad Lagrone seconded the motion. The motion carried unanimously.

After discussion, Councilman Chad Lagrone made the motion to approve placing a culvert at the property of Darrell Morgan. Councilman Edward Lenz seconded the motion. Motion carried unanimously.

Councilman John Paniagua made the motion to appoint Councilman Edward Lenz as Mayor Pro Tem for a one-year term. Councilman Chad Lagrone seconded the motion. Motion carried unanimously.

After discussion, Councilman Edward Lenz made the motion to postpone the TML Intergovernmental Risk Pool Cyber Liability and Data Breach Response Coverage Update until the July 15, 2024 city council meeting to give the council more time to review the information. Councilman John Paniagua seconded the motion. Motion carried unanimously.

Councilman John Paniagua will organize the July 4<sup>th</sup> parade at the football field. Councilman Edward Lenz and Councilman Bryan Woods will cook the hot dogs on the pit. Mr. Neidhart will drive the teenagers around to hand out flags, fans, and water. Everyone will gather after the parade to help with the community hot dog lunch. Note: Folks ate about 405 Hot Dogs and Blue Bell Ice Cream.
